THE RUMPUS ROOM, LLC Admissions Agreement

General Use

Admission is open to all children 2 to 12 years of age, regardless of race, creed, color, or national origin. The Rumpus Room provides a safe, fun, exciting environment for children to play and learn under the care of certified child care professionals. Children in the standard program may stay at the center for up to five (5) hours a day, not to exceed fifteen (15) hours in any given week. Children in the *Corporate Cares* program may stay at the center for up to ten (10) hours per day for up to two (2) consecutive days, but not to exceed twenty (20) days per year. The Rumpus Room does not take field trips or provide transportation to or from the facility.

Future Use

This Agreement and the Release will be kept on file at The Rumpus Room, LLC, and will constitute binding obligations for any future use of the facility. This Agreement does not obligate The Rumpus Room to provide services. The Rumpus Room reserves the right to refuse admission to anyone and terminate use by anyone for any reason at any time without liability.

Fees and Payment

There is a one-time registration fee of \$15.00 per family due at the end of the first visit. Hourly fees for use of The Rumpus Room are \$8.00 per hour for one child, \$12.00 per hour for two children, \$15.00 per hour for three children. Each additional child is \$2.00 per hour. Frequent user cards are available; purchase \$100 or more of time in advance and get a 10% discount. Reservations can be made if you provide a credit card number. Reservations will be held for 30 minutes after the scheduled arrival time and then canceled. Noshows will be charged \$10.00.

The minimum charge will be for one hour. Thereafter, fees will be calculated on a quarter hour basis. Payments must be made for use of the facility and any other items (such as meals) at the time of check-out in cash or by charge/debit card. A credit card may be required at time of drop-off for large groups. No refunds will be given. Any changes in fees will be posted at least thirty days in advance.

If a parent/guardian does not return to The Rumpus Room within the appropriate time limit outlined above, a fee of \$1 per minute will be assessed. If a parent/guardian has not returned within fifteen (15) minutes of the time limit, we will attempt to contact all persons on the child's registration form. If none of these contacts are available immediately, The Rumpus Room will contact the appropriate law enforcement and child welfare personnel.

Meals

The Rumpus Room provides morning and afternoon snacks. Meals may be purchased for a separate fee or a child may bring a meal to eat while at the facility.

Health Policies

The Rumpus Room will NOT knowingly admit sick children. By signing this agreement you agree that your child has no medical, psychological, physical, or mental condition that has not been disclosed to The Rumpus Room on the registration form. You further represent that your child does have any infectious, contagious, or communicable diseases. *Note: Verification of immunizations and tuberculosis testing are not required for attendance at a drop-in child care center.*

In the event that your child becomes sick with a contagious illness after visiting The Rumpus Room and their visit may have coincided with the gestation period of the illness, you agree to notify The Rumpus Room as soon as possible. At its discretion The Rumpus Room may choose to notify other families who may have been exposed. If the staff of the Rumpus Room determines that your child is ill while at the center, the staff will contact you to pick-up your child immediately from the facility.

Medical Procedures

The Rumpus Room is a safe environment designed to be child-friendly. However, it is possible that a child could get injured. In such an event, The Rumpus Room is authorized to take appropriate actions to address an injury. In the event that The Rumpus Room determines that emergency medical attention is necessary for a child, The Rumpus Room is authorized to act as an agent and to give permission for a child to be attended by a physician as necessary.

Non-Medical Emergency Procedures

In the event of a fire, earthquake or other emergency, The Rumpus Room may be evacuated in accordance with the emergency evacuation procedures posted in the reception area.

State of California Licensing Requirements (CCR, Title 22, Section 101200)

The Department or licensing agency shall have the authority to interview children and staff and to inspect and audit child and facility records without prior consent of the parties; to observe the physical condition of the children, including conditions that could indicate abuse, neglect, or inappropriate placement; and to have a licensed medical professional physically examine the children.

Safety and Indemnity

By signing below you hereby agree that The Rumpus Room may take action that it considers prudent to protect the safety of your child and the other children visiting the premises. You further agree to indemnify, defend and hold The Rumpus Room (and its owners, officers, directors, agents, employees, successors, and/or assigns) harmless from and against all actions, claims, or liability (including attorney's fees and court costs) directly or indirectly caused by your child or resulting from any inaccuracy or omission made by you in completing this Agreement, the Registration form, or other information provided to The Rumpus Room.

Release

The Rumpus Room, a California Limited Liability Corporation, provides a safe environment for children. However, injuries may occur. In consideration of the drop-in child care services provided, The Rumpus Room requires a signed release (below) for all children using our facilities.

I, on behalf of myself, spouse, and each child designated on the Registration Form, hereby waive and release all rights, causes of action and claims against The Rumpus Room, LLC, its owners, directors, agents, employees, assigns and successors, for any loss, cost, expense, damage, or injury that I, my wife, and/or child(ren) may suffer arising from my child's/children's visit to The Rumpus Room, including the possible active and passive negligence of The Rumpus Room, LLC, its owners, directors, agents, and employees, but excluding gross negligence and intentional misconduct. I understand that the provision of child care contains risk of injury to persons and damage to property, and that by signing this release I engage The Rumpus Room to provide temporary child care for my child(ren) at my own risk.

I understand that video recordings will be made of all children's activities while at The Rumpus Room for security and insurance purposes, and that these recordings will be kept on file by The Rumpus Room. Further, I authorize use of all photographs and video images of my child(ren) for promotional and advertising materials.

I have been given an opportunity to ask questions and obtain answers to my satisfaction regarding any and all aspects of The Rumpus Room and this release, including, but not limited to, future risks, complications, and costs. By signing this Release, I have not relied on any promises or statements made by The Rumpus Room or its employees other than those contained in written information supplied to me by The Rumpus Room. In addition, I have been given the opportunity to inspect the premises of The Rumpus Room and find it safe and satisfactory for my child(ren).

I understand that this Release will be kept on file at The Rumpus Room and will continue in effect for this and any and all future visits my child(ren) make to The Rumpus Room.

I have read the above carefully and fully understand the content and consequences of this agreement. I agree to abide by and be bound by the above policies and procedures and release. In addition, I agree that the Release is effective against me, my spouse and my children. On behalf of my child(ren), spouse, and myself I consent to the terms of this agreement.
